# **DIRECTIONS FOR USE**

- Switch off engine and fan
- Straighten the provided tube and completely insert into one of the air vents on the dashboards
- Dispense Puri Clima while slowly removing the tube
- Repeat the treatment in all air vents 4.
- Where possible, remove pollen filter and spray Puri Clima in the external air intake
- 6. Wait for 20 minutes then open all windows, switch engine on and turn the fan on to the highest temperature and let the system run for at least 10 minutes
