2. Holding the can upright, spray from a distance of 15-20 cm from surface.
3. Spread with a soft and dry cloth, start cleaning from the parts less dirty.

WARNINGS

Do not apply on hot surfaces or under direct sunlight.

Do not smoke during the use. Provide to ventilate cockpit after use.

SHELF LIFE

3 years minimum. Store tightly closed in the original container in a dry area at temperatures between 5 and 40°C. Avoid direct sunlight.
