- **PRODUCT FEATURES**

Innovative gel formula with neutral pH, produces an active foam for better adhesion of the product on vertical surfaces and more efficient cleaning. Foam change in color after contact with brakes iron powder (from colorless to red/dark purple) shows the cleaning power. Cleans residue from brake pads and hard to remove dirt from wheels. Ready-to-use product. Acid-free. Does not contain silicone.

- **DIRECTIONS FOR USE**

- 1.Spray on the surface thoroughly and leave to act for 3-5 minutes until foam became colored red/purple.
- 2.Remove the dirt using a soft brush, a bottle brush or a sponge.
- 3.Wash thoroughly with water until the product is completely removed. For better results use high pressure.

NOTE: Do not use on hot surfaces and avoid leaving dry the product on the parts before rinsing.

Considering the different types of wheels alloys and treatments, we recommend testing the compatibility of the product on a small hidden area

- **SHELF LIFE**

In unopened packaging, stored at room temperature and away from direct sunlight, at least 3 years.
