## **GASKET SEALING**

#### - DESCRIPTION OF THE PRODUCT

Product with natural resin and alcohol solvent base. It forms a transparent film with excellent adhesive properties. It can be used to hold preformed gaskets in place before assembly.

#### - FIELDS OF USE

As an adjuvant for any type of preformed gasket. Used to seal couplings for engines, machine tools, hydraulic couplings, fuel tanks.

#### - Instructions

Use on clean, degreased surfaces. Spread a thin, even layer with a brush. Proceed with assembly of the performed gasket. Close the surface after about 15 minutes.

Crosslinking may be accelerated by using heat.

In unopened package at ambient temperature and out of direct sunlight: at least 3 years
