# FRESCA FOGLIA BOCCETTINO

### - PRODUCT DESCRIPTION

Liquid perfume in a glass bottle with a wooden cap and a string for hanging on the rearview mirror. The special Ayous wood cap, once soaked, spreads pleasant fragrances in the car.

### - APPLIANCE FIELD

Wooden cap liquid air freshener for hanging on the rearview mirror. Can be hanged on other holders, if used at home.

### - TECHNICAL SPECIFICATION

### - INSTRUCTIONS FOR USE

Extract the air freshener from the blister.  
 Unscrew the wooden cap and remove the plastic plug.  
 Screw the wooden cap. Hang on the rearview mirror with the string provided. Adjust the string length so that the air freshener is free to swing.  
 To activate the product shake it or turn it upside down a few times.  
 Repeat the activation step once a day for a constant and intense perfume.

### - WARNINGS

Carefully follow the instruction for use.  
 Don't soak excessively the wooden cap: the product could leak.  
 Before driving verify that the product is firmly fixed and does not interfere with any instrumentation.  
 The liquid may cause damage on surfaces.  
 In case of accidental leak, clean immediately with a dry cloth and avoid contact with skin and eyes.

### - STORAGE

In closed package at room temperature away from direct sunlight at least 3 years.
