DIRECTIONS FOR USE

Intake: remove air filter. Warm up and keep accelerated the engine (2.000-2.500 rpm), spray little by little the whole content of the bottle into the air manifold.

Carburetor: spray on the external surface thoroughly, leave it for few minutes and then remove dirt with a cloth or compressed air. For internal cleaning, deliver the content directly in the “venturi tube” at regular intervals.
