- PRODUCT DESCRIPTION

Disinfectant and deodorant spray for rooms and surfaces that combats bacteria and fungi. Perfect for disinfecting the passenger compartment of cars, trucks, buses, minivans, campers and mobile homes (total drainage mode); hospital wards, clinics, classrooms and offices (manual dispensing mode). The product does not stain.

- METHOD OF USE

For disinfecting the interiors of cars, trucks, buses, minivans, campers and mobile homes: carefully clean the passenger compartment and ensure that the cigar lighter is not in operation. Open drawers, storage compartments, air vents and close windows. With the engine running, turn the air condition on full, activating recirculation mode and the fan at maximum speed, where necessary removing the pollen filter. Shake the can before use and place it on the floor at the center of the passenger compartment. Press down the button until it is locked in the position of total drainage, leave the compartment and close the doors. Wait for the can to be drained completely and leave to act for at least 15 minutes. Before opening the passenger compartment, ventilate it by opening the doors and removing the residues with a clean cloth.

Manual dispensing mode:

gently press the dispenser button, taking care not to lock it in the total draining position. Dispense and evenly cover the surfaces to be disinfected, leaving the product

to act for at least 15 minutes. Remove the residue with a clean cloth. Repeat.

- WARNINGS

Once the treatment is complete, ventilate the space before entering. Do not use the product in the presence of flames or sparks. Do not contaminate food, drinks or their relative containers/bottles. Do not inhale the spray and do not spray in the eyes.

- STORAGE

The batch number and date of manufacture are indicated on the bottom of the can.
