- **DOSAGE**

5 L are treatment for 2000 liters of diesel.
1 L treats 400 liters of diesel.

"DIESEL MIX", in recommended dosage, ensures pumpability of the fuel up to -20°C (depending type and quality of the diesel).

- **STORAGE**

Unopened and stored at room temperature away from direct sunlight, for at least 3 years.

Metal tank.
