### - PRODUCT DESCRIPTION

**MOTOR OIL ADDITIVE** is an additive specifically intended to stabilize the viscosity of the oil, reducing friction and wear, improving engine performance. It ensures the necessary lubrication even in difficult conditions (old engines, high temperatures etc.).

#### - FIELDS OF USE

For all diesel and petrol engines. Perfectly compatible and mixable with oils currently on the market, both mineral and synthetic based. It does not affect the operation of catalytic converters.

#### - METHOD OF USE

Add the product to the motor oil. After adding, start the engine. Use the additive at every oil change. A 325 ml package is sufficient to treat  $4\div5$  liters of motor oil.

Unopened and stored at room temperature away from direct sunlight, for at least 3 years.
