DIRECTIONS FOR USE

Add the whole content to the old lubricant, just before changing it.

Turn on the engine and let it idle for 10 minutes maximum.

Download the old lubricant treated with **MOTOR CLEAN**, change oil filter, pour new lubricant.

Depending on the usually covered tracks, it's strictly recommended using motor clean:

• Urban tracks: each 30.000 km

• Extra urban tracks: each 40.000 km

Motor clean doesn't affects usual maintenance habits.
